# 1. PRELIMINARY MATTERS:

- (a) Call to Order: Mayor Butikofer called the meeting to order at 6:00 p.m.
- (b) Attendance: Attendance was recorded.

No declarations of pecuniary interests under the Municipal Conflict of Interest Act were brought forward.

# 2. PUBLIC MEETING RELATING TO THE MUNICIPALITY'S REVIEW OF ITS OFFICIAL PLAN

# 2.1. Report from Clerk-Treasurer Regarding Official Plan Review

The Clerk-Treasurer provided an overview of the report. Members of the Committee were given the opportunity to ask questions of the Clerk-Treasurer. There were no questions from the Committee.

2.2. <u>Members of the Audience may address Committee either in favour of, or in opposition to, the Municipality's proposed amendments to the Official Plan</u>

Shannon Dodd Smith spoke regarding the draft Official Plan and the letter she had previously submitted to the Municipality outlining her suggested changes. Ms. Dodd-Smith started by thanking Council for the park amenity improvements in geographic Pearson Township, and noted that the new plan highlighted protected areas and the replenishment of shared spaces to support community building. She stated that she was glad to see a focus on sustainable development and stated that residential growth should not be confused with commercial development. Mrs. Dodd-Smith stated that she does not like to see farmland lost, however was glad to see more community amenities, including medical clinics. She stated she would like to see public access to shoreline protected. She expressed concern that there were no studies to support the deletion of Environmental Protection areas from the mapping, as proposed.

Ms. Dodd-Smith went through her suggested changes, which are also outlined in her correspondence.

Mayor Butikofer asked Council if they had any questions for Ms. Dodd-Smith. Members of Council thanked Mr. Dodd Smith for her presentation and some members stated they needed more time to review her detailed comments.

Mayor Butikofer asked if any other members of public wished to speak. No one else requested to speak.

2.3. Committee will consider the proposed Official Plan changes and make a recommendation to the Municipal Council, to be considered at the regular meeting of the Council, scheduled for April 7, 2021 at 6:00 p.m.

Council asked the Clerk-Treasurer whether the owners of the three properties that are proposed to have special conditions removed from the Environmental Protection designation had been consulted. The Clerk-Treasurer responded that, apart from the general public notice provisions, no individual notices had been sent.

Committee members expressed that they would like more time to consider all of the written comments received prior to making a recommendation regarding the Official Plan.
