## 1. PRELIMINARY MATTERS:

- (a) <u>Call to Order</u>: Mayor Butikofer called the meeting to order at 5:00 p.m.
- (b) Attendance: Attendance was recorded.
- (c) Declarations of Interest:

No declarations of pecuniary interests under the Municipal Conflict of Interest Act were brought forward.

## 2. PUBLIC MEETING RELATING TO THE REVIEW OF COUNCIL COMPOSITION

2.1 Report from Clerk-Treasurer Regarding Council Composition

There was roughly equal feedback through the survey of people wanting to keep the current composition of seven Councillors and people in favour of reducing the number of Councillors.

2.2 <u>Hear from Members of the Public Regarding Council Composition</u>

A list of questions was submitted by resident Tracy Gardner. Her list of question was addressed as follows:

 Councillor Cuthbertson ... How do you see the jobs/committees that you now hold distributed among 4 councillors and who around the table would be willing to take on the work? Please be specific.

Councillor Cuthbertson responded that he only committee where he sits alone as a Councillor is the Lakehead Rural Planning Board. He can not say who would take on that committee work as he does not know who the next Council will appoint. The other committees he is involved with have two or three members of Council on them and he does think than the number of representatives being reduced by one person would have any effect.

2. Councillors Gardner and Coulson...You have both volunteered to do work involved with maintaining and upkeeping the rinks at Blake Hall and Alf Olsen Park. Considering the difficulty in attracting volunteers for these jobs, how do you see this work distributed if one of your seats on council is eliminated?

Councillor Coulson responded that he can still volunteer without being a member of Council, and whomever is on Council will pick up the slack.

Councillor Gardner stated he would still volunteer whether or not he was on Council.

Mayor Butikofer stated that volunteering for Blake Hall, or Alf Olsen Park, or other work, is not part of the Council job description or expectation. A future Councillor may be a person with disabilities, or unable to volunteer for other reasons.

3. If council is to eliminate 2 positions and the workload be absorbed, then can we expect an increase in the amount of honourarium a Councillor receives?

This Council does not foresee an increase in the Honorarium outside of the annual cost of living increase given to all staff. However, Council acknowledges they cannot control the decisions made by a future Council.

The Mayor stated that he did not anticipate the workload to increase and would likely remain as 2 meetings per month on average plus committee work. There is no extra remuneration for participating on committees.

4. Seeing as council is now (since Sept. meeting) moving towards reducing council numbers by combining Pearson/Pardee as one ward, should then all of the tax payers of these two wards be contacted and consulted as this affects them directly?

Various Councillors spoke. Another round of consultation would delay the bylaw. This project has been in the works since 2019: It was in the Neebing News; it was on Facebook; It was on our Website.

Shannon Loukola, a member of the public joined the meeting in person.

A Councillor asked what would happen if the bylaw was approved at Council and a resident appealed the bylaw.

Ms. Kromm stated that the bylaw appeal period is 45 days. In order to allow for the appeal period, the bylaw would have to be passed at the November 3 Council meeting. If there was an appeal it would be addressed by the Ontario Land Tribunal and their ruling is final. The tribunal changed their structure and she does not know the timeline for the new tribunal meetings.

Mayor Butikofer confirmed that if Council chooses to pass the bylaw to reduce Council size, and someone objects, and the tribunal upholds Neebing's bylaw, then the bylaw would take effect in 2026 election period.

The Mayor invited Shannon Loukala to speak. Ms. Loukala asked about public consultation. The Neebing News article in September stated we would consult for over the next months.

Council was asked if anyone had contacted them about this issue. Councillor Gardner has received four calls. No one else received any calls.

Ms. Loukala stated that Neebing should not take a non-response as agreement. This process should have been started earlier. It is not fair to residents. Ms. Loukala asked Council could place an enddate on the survey and advertise the end-date so the public would know that the consultation period is ending.

Ms. Kromm stated that if the process was extended it would not be valid for the next term of Council. She also stated that having a question on the next election ballot may be challenging because often Council seats are acclaimed in Neebing. If there is no election, MMAH may require us to pull the question. If Council chooses, the survey can run until to November 3 at noon, and we can advertise that fact on Facebook and on the website.

## 2.3 Debate from Council

Councillor Gardner stated that once the new Council is in charge, he does not know if the Honorarium will change. He prefers the seven-member Council as each Councillor brings a different set of skills to the table.

Councillor Coulson stated that he supports the existing seven Councillor composition, however he can also see the reasoning behind why the change is being recommended. He stated that more volunteers might lighten the load.

Councillor Cuthbertson stated that he has dealt with neighbouring Municipalities that function with five Councillors. He acknowledged Councillor Gardner's comment about diversity of skill, but he still supported a Council comprised of five members.

Councillor Wright stated that he had mixed thoughts about the issue. He noted that other Municipalities function well with five Councillors and that overall he thinks that five will be enough for Neebing.

Councillor Kurikka stated that he has a 50-50 opinion on this issue. He noted that Neebing does not have in-house expertise and we have to hire expertise. The next Council will have the same issue. He acknowledges that skill is picked up by the committees, so he would support either outcome.

Councillor Thibert stated he has received no feedback from residents and is voicing his personal opinion. He has been a part of a number of organizations that have undergone downsizing and he supports an approach that favours saving money, so he supports a five-member Council.

**CLERK-TREASURER** 

Mayor Butikofer stated that he favours downsizing. He would rather see funds directed to more staff, rather than more management. There is no guarantee who will run, and no guarantee of their skill set. Overall, he represents Neebing and Neebing will still be represented by a five-member Council.

Shannon Loukala was thanked for her participation in the meeting.

## General:

- 3. <u>Economic Development</u>: The Thunder Grinder event has passed but Administration is still working with NOHFC to complete the paperwork for the funding. The event organizers are interested in working with Neebing again and possibly looking at expanding on future cycling events.
- 4. <u>Landfill Site Work</u>: KGS submitted the Environmental Assessment Application for the Scoble Landfill expansion to the Province for review. KGS is preparing for the work related to an additional monitoring well at Scoble as well as the annual testing program for both sites.
- 5. <u>Waste Management</u>: The FoodCycler units arrived at the municipal office on October 28, 2021 and Administration will be working to distribute the units over the next week. There is still one spot available in the trial.

#### Dear Head of Council:

I am writing to provide details on 2022 funding allocations under the Ontario Municipal Partnership Fund (OMPF). We are announcing allocations today – the earliest they have ever been announced because we know that municipalities need this information as early as possible to support municipal budget planning.

Municipalities have stressed the importance of stability and predictability in these uncertain times. Our government is responding by maintaining both the structure of the OMPF and the program envelope at \$500 million for 2022.

Maintaining the current structure of the OMPF for 2022 means that the grant components and transitional assistance funding guarantees of the program will remain. The program will continue to be responsive to changing municipal circumstances through annual data updates and related adjustments.

I am also pleased to confirm that maintaining the program envelope at \$500 million will allow for further support to be targeted to rural farming municipalities. Specifically, rural municipalities with the highest levels of farmland will receive additional funding of up to \$5 per household.

As in prior years, Transitional Assistance will ensure that the 2022 funding guarantee for municipalities in northern Ontario will be at least 90 per cent of their 2021 OMPF allocation and for municipalities in southern Ontario will be at least 85 per cent of their 2021 OMPF allocation.

Northern and rural municipalities with the most challenging fiscal circumstances will continue to have their guarantee enhanced up to 100 per cent of the prior year's allocation.

The Ministry of Finance's Provincial-Local Finance Division will be providing your municipal Treasurers and Clerk-Treasurers with further details on the 2022 OMPF. As you know, the Province has provided significant support to Ontario's municipalities to address the critical public health and economic challenges brought on by the pandemic. This includes almost \$1 billion in financial relief for municipalities in 2021 as well as \$4 billion in joint funding with the federal government through the Safe Restart Agreement in 2020 to support municipal operating and transit pressures.

Our government is committed to supporting municipalities in a way that is sustainable and responsible. Working together, we can achieve remarkable things for Ontario.

## RECOMMENDATION:

Administration seeks Council direction with regards to proposed changes to Council Composition.

## **BACKGROUND / DISCUSSION:**

This report is largely a duplicate of the report provided to Council at the meeting on October 27. Some updates have been provided in this report and are in blue text for ease of reference.

One of Council's strategic goals is to complete a review of the composition of Neebing Council and the possibility of reducing Council to five members. In the fall of 2019, a series of articles was published in the Neebing News seeking input from the public on this matter. Very few comments were received and in September 2021 Administration put out a survey to obtain further comments. The results of the survey are summarized in Attachment One.

In addition, Council held a public meeting on September 29, 2021 to provide an opportunity for in person feedback. Attachment Three is a copy minutes from that meeting which summarizes the comments received. At this meeting, it was discussed with attendees that Council was interested in pursuing a 5-member Council which wouldn't have an at-large position and would combine the Pearson and Pardee wards. It was suggested that a follow-up survey could be circulated to receive feedback on this proposal. At the October 6, 2021 regular Council meeting, Administration as directed to circulate the follow up survey. The results of this survey are attached at Attachment Two.

The purpose of this meeting is to review the comments received from the public and debate the proposed changes to Council Composition.

At the time this report was written, 97 responses had been received for the original survey and six responses had been received for the follow-up survey. In addition, seven individuals have submitted comments by mail or email. There were four comments received in 2019, it is not known if those individuals also completed the 2021 survey. The responses are fairly split down the middle between those who are in favour of the change versus those who are in favour of the status quo. While we don't expect to have 100% participation in this type of consultation, 108 responses is not very representative of the population and there is no clear direction from the public.

Since this report was originally circulated, one additional survey was received by fax, one was received online and one response was received online to the follow-up survey.

The proposed changes have the greatest impact to Pardee and Pearson. There were 18 responses from Pardee and Pearson and a summary of their responses is listed below:

- 1. 12 prefer the ward system.
- 2. 12 of the responses want to keep the existing wards
- 3. 9 of the responses prefer a 7-member council

As set out in Section 222 of *the Municipal Act, 2001*, municipalities wanting to create, dissolve or change ward boundaries are required to comply with certain processes and requirements, including:

- passing a by-law that sets out the new ward boundaries or at-large structure
- providing notice of the passing of the by-law to the public within 15 days
- specifying the last date for the public to file a notice of appeal of the by-law

If Council wishes to move forward with the change, Administration would bring forward a by-law for adoption at the November 3, 2021 regular Council Meeting. This would allow for the 45 day appeal period before the change can become effective by the end of the year. If the by-law becomes effective by the end of 2021, then the change will take effect for the 2022 election. If someone submits an appeal, then the matter would be directed to the Ontario Land Tribunal to schedule a hearing. In this case, the by-law would not be effective until the Tribunal has a hearing and makes a ruling. Any hearings with the Tribunal likely would not take place until 2022 which means the by-law would be in effect for the 2026 election, if approved by the Tribunal.



A ward representative has a personal stake in your geographic area. He/she will truly be in touch with their constituents.


Ward councilors are vital for fair representation of the varying priorities residents of Neebing may have – some areas have higher population densities, whereas other areas have people who own larger parcels of land. Some residences on the lakefront have a higher monetary property value, which may result in more credence being given to their priorities. However, the ecological value of most of the area in Neebing is invaluable (for example the carbon sink and water retention capacity of wetlands, including but not limited to the provincially significant wetland in Pearson) even though the 'property values' may be less. On the other hand, at-large councilors are not beholden to a given ward and can make decisions based on the best interest of the whole community. It is a difficult balance, and in the end, it rests on how good of a job council does. However, small government does not necessarily benefit the residents of a community, and should not be a goal in itself (the monetary savings are not that significant – if they are in fact \$20,000/yr).

I feel we have too many councillors and it should be reduced. Also in a small municipality the councillors should represent everyone

Council should be responsible for all areas of the municipality and know the whole municipality and needs of the residents





# 7. In which Ward (geographical township) do you live?







## **PRELIMINARY MATTERS:**

- (a) Call to Order: Mayor Butikofer called the meeting to order at 6:00 p.m.
- (b) Attendance: Attendance was recorded.
- (c) <u>Declarations of Interest:</u>

No declarations of pecuniary interests under the Municipal Conflict of Interest Act were brought forward.

## PUBLIC MEETING RELATING TO THE REVIEW OF COUNCIL COMPOSITION

#### 1.1 Report from Clerk-Treasurer Regarding Council Composition

Council is proposing a reduction in the number of Councillors from 7 to 5 people, and Council also requested feedback as to how that could occur. Ms. Kromm highlighted the number of ways that the reduction in Council members could occur.

The Mayor spoke in support of the Council size reduction. He listed the population of each of the wards and stated that most surrounding Municipalities have five Councillors and by reducing Neebing to four Councillors and a Mayor that the expected cost savings of \$20,000 could be used by the Municipality towards other budget items.

## 1.2 Hear from Members of the Public Regarding Council Composition (

Bill Lankinen spoke and stated he disputed the amount of the savings and while he was not opposed to the reduction in the number of Council representatives from seven to five, he was strongly opposed to having the representation all from one area of the Municipality. He also inquired if Councillor received separate remuneration for being on committees and was informed that they do not receive extra remuneration.

Mayor Butikofer stated the savings would be applied to other areas. Mayor Butikofer and other Councillors spoke of how each Councillor representing Neebing as a whole.

Shannon Loukala spoke and stated she also did not believe there would be \$20,000 saved. Ms. Loukala stated she thinks something will be lost by the reduction in the size of the Council and she is not is support of the reduction. She stated her father informed her that when amalgamation occurred the deal was that each area would have representation. Ms. Loukala is also not in favour of having all Councillors from the same geographic area of the Municipality.

Councillor Coulson stated that he personally supports the existing system, however he can also see the reasoning behind why the change is being recommended. He stated that in the past Pearson and Pardee had their own recreation organization.

Councillor Cuthbertson stated there are problems finding people to run for Council. Scoble has had no one from Scoble wanting to run for the past three terms. In the last election all the Councillors were acclaimed and the only election was for the position of Mayor.

Gertrude Belanger spoke and stated that there are areas within the Municipality that have specific interests such as Oliver Lake, and those areas would still want to have representation.

Ev MacGray asked what the online survey results showed. Ms. Kromm responded and said there were 32 respondents and that approximately 40 % were in favour of five Councillor and 60% in favour of maintaining the existing system.

Tracy Gardner stated that the survey had several options, and that the number of options was concerning, and that people were apprehensive. She asked what process would be followed prior to making a decision, and where does public opinion fit into the decision

The Mayor stated that that Council wanted to know if residents wanted to have representation by numbers or neighbourhood. He informed Mrs. Gardner that there were attempts to engage the public in 2019 with newspaper articles regarding Council Composition and there was no response. He stated that what Council would likely discuss is Council representation from Pearson/Pardee, Blake, Scoble, Crooks and a Mayor.

Mrs. Gardner said that was not clear on the survey. No one wants to lose their Councillor. She asked it the survey could be condensed to two options.

Mrs. Gardner also stated that because Pearson and Pardee represent about ½ of the area's geography, she had concerns about the workload for that Councillor.

Councillor Wright reiterated that Council works as a whole to solve the problems of the Municipality, and that workload would be shared amongst the Councillors.

The Clerk-Treasurer stated that the survey provided all options to reduce the size of Council, as Council had not yet indicated a direction for any one form of representation. She will bring a report to the next Council meeting so Council can provide direction.

## 2. ADJOURN THE MEETING:

There being no further business to attend to, Mayor Butikofer adjourned the meeting at 7:28 p.m.

Thank you for the invitation to participate in consideration of the makeup of Neebing municipal council as appeared in the Neebing News, September 2021 issue.

In answer to the article's three questions:

- a. It is essential to maintain ward councillors to represent the diverse interests of taxpayers in the wards. Direct representation would be diluted or lost if citizens were asked to vote entirely at-large, and successful candidates attempted to speak for all residents at once. Or worse, if they sought to speak collectively for a constituency that might seek to influence them on matters that did not serve the interests of the municipality as a whole or those of one or more of its wards.
- b. Neebing is, I believe, the second-largest municipality by size in Ontario. I don't think that many of its residents are aware of wards much beyond their own and certainly not other wards' particular issues. Residents would need this council to present a 'guide to wards' in order for people to get some idea of whether the existing ward boundaries provide an accurate division of interests and issues.
- c. A smaller council is, in theory, an opportunity for more efficient discussions at the council table and a way to save some money. The suggested number of five members lends itself to consideration of different forms of representation. For example, three wards comprise the large majority of Neebing's population. Do the two much less populous wards each need a councillor or might one representative be sufficient to speak to their similar combined interests? A reorganized council might even see new ward boundaries redrawn around primary land uses -- lakeshore, inland residential, industrial (farming and forestry). The current single at-large position seems irrelevant in this scenario (no offence to Councillor Cuthbertson). A wards study with input from interested residents would be helpful.

Any consideration of council representation must, in my view, include the core issue of taxation and how it is applied across Neebing's neighbourhoods.

Taxes at this address have risen steadily and remarkably to levels consistent with homes in the City of Thunder Bay with its vast array of public services. While recognizing Neebing's limited population and tax base, all Neebing residents receive landfills, roads and infrastructure maintenance directly from the municipality. As lakeshore residents on approximately one acre of land, is it fair that my wife and I are forced to subsidize use by most lesser-taxed inland residents, often on much larger properties, of those same Neebing services solely because we happen to live on Lake Superior? I put it to you that it is highly unfair and, for that reason, I would hope that the issue of how Neebing is governed is broadened to include how Neebing is taxed.

#### Good morning,

This message is in response to the request for input from Neebing residents recently posted in the Neebing News. My name is Mitchell Taylor (66 Cottage Drive West), Crook's Township.

With respect, I think you are going about this in the wrong way. Having all the councilors as "at large" does not serve to ensure regional representation, or representation in proportion to population, or representation of any other socioeconomic strata in Neebing (such as lakeshore subdivision residents, off-lake residents, farmers, forest industry properties, renters, business, and non-resident property owners). What purpose are you trying to achieve with the system you are proposing? Where are the residents of Neebing living and how does the system work for them (e.g., MPAC method for taxation)?

I am concerned that having all councilors "at large" would render the council vulnerable to activist special interest groups that would not consider the Municipality as a whole. I also agree that just using the historical system without evaluating it or discussing it doesn't make sense either. But the key question is not how many councilors should Neebing have. The key question is what are Neebings main socioeconomic groups and how are they distributed. It doesn't have to be by area. Individuals could self-declare by category or it could be done by mapping types and thus assigning property (voters) into types.

Underlying all is the democratic principle of equal representation while ensuring respect for minority perspectives and human rights.

I think you are trivializing this important issue without walking the Municipality through the many considerations and options available. Redistribution of representatives can be a good thing for the Municipality, but it can also result in mistrust and a lack of confidence in government. Who were the winners and who were the losers?

Why 5? Why 7? Why not 3 or 10? This needs to be driven by demonstrated need and a careful consideration of what will function best, not picked on some vague preference like an ice cream flavor.

It's a big job, and good for you for bringing it up. But I don't think Neebing is ready to vote on any of these choices yet. It needs a lot more public discussion first.

## **RECOMMENDATION**

Administration requires direction regarding the format and location of future Council meetings.

#### **BACKGROUND**

Since mid-2020, Neebing's Council meetings have been held via web conference in wake of the COVID-19 pandemic. In this ever evolving situation, we have experienced various forms of lockdown and restrictions as cases rose and fell. Council reviewed the possibility of moving back to in-person meetings in September, but opted to continue with virtual meetings into the fall. This was to wait and see what would happen with the fourth wave. The district has maintained a relatively low case count throughout the fall and the province has recently released its plan to begin lifting covid safety measures. Administration is requesting that Council review the matter again to determine if they wish to make any changes to how Council meetings are held.

#### DISCUSSION

The options for future meetings would be one of the following:

- 1. Continue with online meetings
- 2. Move the meeting location to the Blake Hall with or without online participation
- 3. Return to meeting in the Council Chambers with or without online participation

Throughout the past year, Administration has been preparing the Blake Hall for Council meetings. The eventual goal will be to host hybrid meetings from Blake Hall. Meaning people could participate in person as well as online.

To date the following upgrades have been completed:

- Internet installed
- Polycom system purchased and equipment tested (this allows web conferencing from Blake Hall)

The following upgrades still need to be completed:

- Installation of AV equipment (speakers), which are on backorder and have no estimated time of arrival.
- Purchase of an Owl camera system
- Installation of an HVAC unit at Blake Hall for better air circulation

To date no modifications have been made to the Council Chambers to make it suitable for meetings at this time. While the Polycom system could be set up in the Council Chambers, the current Council table does not accommodate the required 6 foot spacing.

There is a booking conflict with the regular Wednesday council meeting time, if Council wishes to begin meeting at the Blake Hall. There is a long standing booking with a line dancing group up. This would have to be addressed before the meetings could begin at the Hall. It is possible that any adjustments to Hall bookings could be temporary, as the provincial plan is to remove all or most restrictions by March 2022. This is dependent on continual improvement in the covid case count.

#### **RECOMMENDATION**:

Administration recommends that Council send the attached insert with the arrears notices.

#### **DISCUSSION**:

Since March 1, 2021 penalties on overdue tax arrears were cancelled. This penalty forgiveness provided taxpayers with flexibility to adjust payments during the COVID Pandemic. Now that Ontario is returning to more normal operation, and the office is open for payments, Council determined that penalties will be applied for overdue balances as of October 31. In addition to applying penalties, a notice of arears due is also mailed to ratepayers whose balance is \$5.00 or higher, advising them of the arrears balance.

For ratepayers who have an outstanding 2021 tax balance, the notice of arrears should suffice. For ratepayers who have a 2020 or older tax balance, then the Deputy Clerk-Treasurer would like approval to send the attached notice with the notice of arrears. You are being asked to review and approve this notice, as it deviates from the sample personalized letters approved in the tax collection policy.

If your arrears notice shows a tax balance that you think is incorrect, please call the office and let us know.

If you do not have a payment plan, or have been making only occasional payments, your property may be eligible for tax sale. Please check the enclosed Tax Arrears Notice and read on ...

#### The oldest arrears dictate what will happen to your property.

- If your property has tax arrears from **2018** or earlier, your property is currently eligible for tax sale. The first step of the tax sale process will occur in December 2021 and your tax account will be charged a fee of approximately \$550 unless the arrears are paid or you enter into a payment arrangement.
- If your oldest tax arrears are from **2019**, your property is eligible for tax sale, and will go for tax sale in early 2022 unless the arrears are paid or you enter into a payment arrangement.
- If your oldest tax arrears are from **2020**, your property is eligible for tax sale in 2022, and will go for tax sale in late 2022 unless the arrears are paid or you enter into a payment arrangement.

#### TAX SALES – What you need to know

There are several steps to the tax sale process and each step will add fees of between \$400-\$700 to your property tax. Once a property has been registered for tax sale, the entire balance of the property tax, all the penalty interest and any fees are due in full in order to release the property from the tax sale process.

#### PENALTIES – What you need to know

Penalty Interest is applied to overdue tax accounts at a rate of 15% per year. The Municipality's rates for penalties and interest are significantly higher than today's bank and credit union rates for loans or mortgages. It may be in your best interest to speak with a financial advisor and arrange alternative financing.

#### RECOMMENDATION:

Administration recommends that Council apply for expanded Blue Box Collection.

#### **DISCUSSION:**

Neebing's landfill sites offer depot collection service of Blue Box material. Municipalities that participated in the Blue Box Program on August 15, 2019 are eligible to receive recycle services supplied by producers. The only services producers must supply are those that were available August 31, 2019. In 2019 Neebing offered the recycling of plastics number 1 & 2.

Recently, the City of Thunder Bay applied to the Resource Productivity & Recovery Authority (RPRA) expand their recycle collection to plastics 1-7.

If Neebing would like to expand our plastics collection, we have to submit a Blue Box Program Change Eligibility Assessment Form. However, according to the RPRA, even if we submit that form, expanded service may not automatically be extended to depot sites such as Neebing. The RPRA informed us that more information will be available by July

From a report on Canada Post-Consumer Plastic Recyling – 2018, prepared by MORE Recycling for the Canadian Plastics Industry, 92% of plastic material collected was reclaimed in Canada or the U.S. The percent of plastics reclaimed in Canada in 2018 are as follows:

Of plastics recycled in Canada in 2018 26% were numbers 3-7. In 2019, Neebing recycled

29.45 tonnes of combined Fibre, Glass, Aluminum, Steel, Plastic material. GFL estimates that plastics made up 8% of that material. If the plastic diversion increased 25% in Neebing, this would result in addition diversion of approximately 0.59 tonnes per year.

Diversion benefit (because of landfill capacity extension) would be roughly \$6,000 per year in reduction of landfill closure and post - closure liability.



Please be advised that the Council of The Corporation of the Municipality of Leamington, at its meeting held Tuesday, September 14, 2021 enacted the following resolution:

No. C-279-21

WHEREAS residents and staff at long-term care (LTC) homes have been disproportionately affected by COVID-19; and

WHEREAS in the first wave of the pandemic (March - July 2020) there were approximately 5,488 resident cases and 2,290 staff cases in Ontario and tragically 1,817 residents and seven staff lost their lives to this disease; and

WHEREAS on 15 April 2020, Premier Ford stated, "we will stop at nothing to protect those who cannot protect themselves. Today we are launching an all-out plan to fight COVID-19 in our long-term care homes. We will fortify the iron ring of protection around our long-term care residents and those who care for them. We'll go further in our testing, screening, surveillance, targeting the homes facing outbreaks"; and

WHEREAS there have been approximately 9,417 resident cases and 4,217 staff cases in Ontario in the second wave (2 September 2020-16 February 2021) and 1,869 residents and three staff lost their lives, representing an increase of resident deaths from the first to second wave; and

WHEREAS for-profit LTC homes have seen a disproportionate incidence of care failing to meet the standard of the Long-Term Care Act, which states that "...a long-term care home is primarily the home of its residents and is to be operated so that it is a place where they may live with dignity and in security, safety and comfort and have their physical, psychological, social, spiritual and cultural needs adequately met"; and

WHEREAS the Canadian Armed Forces (CAF) report dated 20 May 2020 revealed conditions including inadequate staffing levels and training, limited medical supplies, unsafe medication administration, insufficient procedures to reduce the spread of

COVID-19, poor infection prevention and control standards of practice, deficiencies in infrastructure and significant concerns about standards of care including seniors calling out for help, rotting food, missed meals, seniors left in soiled diapers and linens and cockroach and bug infestations; and

WHEREAS similar conditions were found in the second wave, including ongoing shortages of qualified, trained staff, ineffective use of PPE to prevent COVID-19 transmission, violation of protocols and practices including one instance in which residents who had tested positive for COVID-19 had their door handles removed, physical distancing and isolation challenges from continuing to house several residents in ward rooms with a shared bathroom and ongoing infection prevention and control standard concerns, all problems that were not fixed after the recommendations of the CAF;

WHEREAS the Provincial Government has launched an independent commission to investigate COVID-19 spread within LTC homes, how residents, staff and families were impacted and the adequacy of measures taken by the province and other parties to prevent, isolate and contain the spread; and

WHEREAS the Association of Municipalities of Ontario (AMO) has provided a Board-approved submission, Improving the Long-Term Care Outbreak Response in Ontario: Submission to the Long-Term Care COVID-19 Commission, on 29 January 2021, outlining recommendations to the Commission on behalf of the municipal governments that operate 100 of the 626 long-term care homes in Ontario; and

WHEREAS AMO's submission puts forward 48 recommendations for action in both public and private long-term care homes across nine themes: Vision for Long-Term Care and Leadership Culture, Public Health and Safety, Planning and Communications, Staffing Measures, Care for Residents, Funding, Inspections - Enforcement and Compliance, and Mental Health and Well-Being; and

WHEREAS one of the key recommendations of the AMO submission is that the Ministry of Long-Term Care and Ministry of Health review the adequacy of infection prevention and control programs under the Long-Term Care Homes Act, 2007 in preventing and managing COVID-19 outbreaks, and to institute higher standards with increased funding to homes to implement these standards; and

WHEREAS the Canada Health Act's aim is to protect, promote and restore the physical and mental well-being of residents of Canada, and that the Federal Government provides health care funding to Provinces and Territories through the Canada Health Transfer; and

WHEREAS the Federal Government does not currently provide funding earmarked to support the LTC home sector, and;

WHEREAS the Federation of Canadian Municipalities (FCM) works with and advocates to the Federal Government to secure new tools and empower municipalities to build stronger communities; and

WHEREAS the operation of LTC homes is a municipal responsibility in Ontario but is of significance to the federal-municipal relationship.

#### NOW THEREFORE BE IT RESOLVED:

THAT Learnington Municipal Council endorses AMO's recommendations contained in its submission to the Long-Term Care COVID-19 Commission;

THAT Learnington Municipal Council strongly urges the Provincial Government to move forward with implementation of these recommendations, including instituting higher standards with increased funding to homes to implement those standards;

THAT Leamington Municipal Council advocate to the Federal Government to enhance federal health care funding to the Provinces and Territories, specifically dedicating funding to long- term care, and to undertake further efforts to protect, promote and restore the physical and mental well-being of long-term care residents in Canada;

THAT Learnington Municipal Council request the FCM to develop a policy and advocacy position on enhanced federal support for long-term care;

THAT this resolution be sent to the Prime Minister of Canada, the Premier of Ontario, the Federal and Provincial Ministers of Health, and FCM for their immediate action and that a copy be sent to AMO, and Windsor-Essex Members of Parliament and Provincial Parliament for their information;

AND that a copy of this resolution be sent to all Ontario upper-tier and single-tier municipalities for their endorsement.

Hello,

The Ministry of the Environment, Conservation and Parks is seeking input on two regulatory proposals currently posted on the Environmental Registry connected to the 2019-2020 Annual Report from the Committee on the Status of Species at Risk in Ontario (COSSARO). Ontario is committed to providing protections for species at risk.

On January 27, 2021, the ministry received COSSARO's 2019-2020 Annual Report, which includes new species classifications made by COSSARO, which included the classification of Black Ash as an Endangered species. Black Ash was not previously classified as a species at risk in Ontario. The *Endangered Species Act, 2007* (ESA) requires the Species at Risk in Ontario (SARO) List (SARO List regulation) to be amended within one year of the ministry receiving COSSARO's annual report (i.e., by January 27, 2022) to reflect the new species classifications made by COSSARO. Once the SARO List regulation is amended, species classified as Endangered and Threatened receive automatic species and habitat protection under the ESA. Conditional exemptions are not automatically available to species that are newly listed in the SARO List regulation.

In response to the receipt of COSSARO's Annual Report, the ministry is proposing two amendments:

 The ministry is proposing to make a regulation that would temporarily suspend protections for Black Ash afforded under the ESA for a period of two years from the time the species is added to the SARO List regulation.

Black Ash trees are found throughout Ontario and protecting the species is likely to result in social and economic implications for Ontarians. This pause will allow the ministry time to gather scientific and socioeconomic information to develop an approach that balances the protection of the species with social and economic considerations. This includes impacts related to forestry, development, infrastructure, and agriculture industries because Black Ash trees are broadly distributed and may not be easily avoided when undertaking these activities. The ministry plans to develop a recovery strategy for Black Ash within a year of its listing on the SARO List, and to develop species-specific policy direction for species recovery within 9 months of the publication of the recovery strategy. (notice number 019-4278).

 Amend O. Reg. 242/08 - General Regulation under the ESA - to allow the use of existing conditional exemptions for select newly-listed species that will be added to the Species at Risk in Ontario List regulation in January 2022.

These conditional exemptions allow proponents to carry out eligible activities (those that have common and routine mitigation actions with well understood requirements to reduce impacts on species), without having to obtain an ESA permit or agreement. (notice number 019-4280).

We invite feedback and input from the public, Indigenous communities and stakeholders on these proposed changes, so that we can continue to help preserve Ontario's rich biodiversity for generations to come.

#### THE CORPORATION OF THE MUNICIPALITY OF NEEBING

#### **BY-LAW NUMBER 2021-043**

Being a by-law to change the composition of Council, and to change ward boundaries for the Municipality of Neebing.

#### Recitals:

- 1. Section 217 of the *Municipal Act*, 2001 S.O. 2001, c. 25, as amended, provides that a municipality may change the composition of its Council, subject to certain prescribed rules.
- 2. Section 222 of the *Municipal Act*, 2001 S.O. 2001, c. 25, as amended, provides that a municipality may pass a by-law to change ward boundaries.
- 3. Neebing considers it appropriate to reduce the size of Council from seven members to five members by removing the Councillor at-Large seat, and by combining two of its five wards, being the Pardee and Pearson Wards.

## NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF NEEBING ENACTS AS FOLLOWS:

- 1. Neebing Council shall be comprised of five members of Council as follows:
  - a. The Mayor, who shall serve as Head of Council and be elected at-large in accordance with the provisions of the *Municipal Elections Act*, 1996, S.O. 1996, c. 32, as amended, and shall have the duties and the responsibilities of the head of municipal Council as set out in the *Municipal Act*, 2001 S.O. 2001, c. 25, as amended.
  - b. Four (4) Councillors, who shall be elected by ward vote in accordance with the *Municipal Elections Act*, 1996, S.O. 1996, c. 32, as amended, as follows:
    - i. One (1) Councillor elected by the eligible electors in the geographical Blake Township (Ward 1);
    - ii. One (1) Councillor elected by the eligible electors in the geographical Crooks Township (Ward 2);
    - iii. One (1) Councillor elected by the eligible electors in the geographical townships of Pardee and Pearson (Ward 3);
    - iv. One (1) Councillor elected by the eligible electors in the geographical Scoble Township (Ward 4);
- 2. This By-law shall come into effect subject to and in accordance with Subsections 217 (3) and 222(8) *Municipal Act*, 2001 S.O., c. 25, as amended, for the 2022 election.

3. All previous by-laws inconsistent with the foregoing are repealed.
